**THE DELRAY AFFAIR
FOOD VENDOR AGREEMENT AND VENDOR INDEMNITY FORM**

Please read carefully before submitting an application. If you are unable to meet our criteria, please do not apply.

The Food Vendor agrees to the following:

- 1) All menu items must be approved by the Delray Affair. You will be asked to remove any unapproved product.
- 2) If the Delray Affair accepts sponsorship from a food or beverage vendor, all Food Vendors must adhere to any contractual agreements of the sponsorship with regard to product sales.
- 3) There is no access to electricity and water. Any generator that can be heard outside of the confines of your booth space is not allowed.
- 4) You must return your space to its original condition and may not encroach on other vendors space.
- 5) You must obtain all permits and licenses required by the City of Delray Beach, Palm Beach County and the State of Florida.
- 6) Proof of Insurance listing the Greater Delray Beach Chamber of Commerce and Festival Management Group must be received in order to register for the Delray Affair.
- 7) You must collect and pay all sales taxes due to the State of Florida.
- 8) Food Vendors must adhere to the Show's "Rules of Participation and General Policies".
- 9) Refunds are given prior to January 1, 2010 less a \$75 cancellation fee.
- 10) Please note that set up is difficult and you will not have vehicular access to your booth during the hours the show is in operation and a suitable period before and after. If you have any concerns, please discuss them prior to your arrival.

Your return of the registration materials indicates your understanding and acceptance of the Rules of Participation and General Policies, as they apply to sales of food for consumption on the premise, copies of which are enclosed.

A RULES COMMITTEE CONTINUALLY ENFORCES THE RULES OF THE DELRAY AFFAIR TO ENDURE THAT ALL WORK SHOWN IS IN COMPLIANCE WITH THESE GUIDELINES. VIOLATION OF THE RULES WILL RESULT IN IMMEDIATE EJECTION FROM THE DELRAY AFFAIR WITH NO REFUND (WE'RE NOT KIDDING). THIS ACTION WILL RESULT IN THE BANNING FROM FUTURE PARTICIPATION.

During the term of this agreement, the vendor assumes all risks in connection with the permitted activity and shall be solely responsible for damage or injury, of whatever kind, to person or property, directly or indirectly arising out of or in connection with the permitted activity or the conduct of vendors operation. Vendor hereby expressly agrees to hold harmless the Delray Affair, Greater Delray Beach Chamber of Commerce, Festival Management Group, its agents, volunteers, employees, officers and directors for penalties for violation of any law, ordinance or regulation affecting its activity and from any and all claims, suits, losses, damages or injuries directly or indirectly arising out of or in connection with the permitted activity or conduct of its operation or resulting from the negligence or intentional acts of vendor or its officers, agents or employees.
